Hello Partners! Welcome back to the [Night Owl](#) 🦉, your nightly recap of need-to-know information and intel on what's happening under the Gold Dome.

Today's energy debates took center stage as Georgia Conservation Voters hosted its 2026 "100% Day" under the Gold Dome, bringing advocates from across the state to push for a more affordable and renewable energy future. The advocacy day comes at a pivotal moment, following recent Public Service Commission elections that signaled growing voter frustration with rising utility costs amid record profits. Despite that mandate, the approval of a massive Georgia Power expansion late last year continues to raise questions about who truly benefits from the state's energy decisions.

Heads up to anyone tracking Certificate of Need policy: Senator Bill Cowser indicated that legislation on the issue will be discussed on Thursday, February 5.

Adding to an already dynamic day, Republican health care executive Rick Jackson entered the governor's race in a surprise move, underscoring how quickly the political landscape is shifting as session unfolds.



Q: Is there any specific person you'd like to see run for president in 2028?



Most Americans see an immigration officer's fatal shooting of Minneapolis resident Renee Good as an inappropriate use of force, a new CNN poll conducted by SSRS finds.
